IV. <u>Discussion of Objective Success Definitions</u>

The team discussed key factors that would signal success on each objective:

Objective 1: Increase state, regional and local level collaboration and program integration

- Structures, councils, committees' ability to participate in the program integration
- Include councils and community groups; currently some groups are tasked with attending meetings across systems that they don't get paid for and are stretched to their limits trying to attend these meetings. If there is a way to streamline it would be productive and fruitful for those attending
- Increased regular and consistent communication so people, groups and community know what's happening
 - Success looks like the information getting from the state-level down; streamlined forms since they all collected the same data
 - Getting communication out in a reliable way
- To resolve disconnect between K-2 and early childhood at the state and local level
 - Build a stronger alliance with all the providers we can locate that would send students to schools
 - Clear, consistent communication between providers and providers to k and the school system
 - Students will be well prepared for success
 - Common training and professional development

Objective 2: Enhance family navigation of integrated programs and services

- Unified forms
- Receiving faster services; quicker time frame for the youngest of children
- Someone to assist with getting the right applications in the hands of families
- Better outcomes: fewer referrals to DCYF, fewer kids waiting in emergency departments, early intervention
- Families knowing what's available; navigators within the family resource centers to help families understand their options
- Providers (ex. pediatricians) being able to direct families according to their needs;
 global understanding of the system
- Having an online format for families to navigate the system by themselves (user-friendly and helpful)
- Family facing website (SC has this system where families can check eligibility for 40 services at a time and shows them how to connect with those services https://first5c.org/)



 Family Outreach Specialist – tasked with building networks with local providers; create communication from identifying those who would benefit from a more robust preschool experience

Objective 3: Increase community voice and influence in design of programs and services

- State talking with communities to find out what they need
- Create community plans on how to address issues and concerns having regular meetings; regional and local communities can apply for funds in their local area
- As programs are designed, base them on community input and as they are delivered, there is flexibility in them that communities can direct and decide what works and what doesn't
- Local programs
 - In housing, coordinated entry meetings
 - Use of Wraparound Teams (was used before) looking at case level data as a community and figuring out how to address issues
- Regional Childcare Director Network
- Use of family resource centers as a place to get community input (have a more active role)
