III. <u>Document Sharing Mechanism</u>

The team discussed mechanisms for sharing and collaborating on documents. DHHS members cannot access external file sharing systems. Greenway Strategy Group is pursuing a solution.

IV. <u>Discussion of Objective Success Definitions</u>

The team brainstormed key factors that would signal success on each objective.

Objective 1: Increase early intervention and primary prevention

- Lack of waitlist for services
- Increase in enrollment/engagement in early intervention and services program
- Increase in school readiness numbers for kindergarten
 - Decrease in behavioral challenges in kindergarten
- Increase in screenings for early intervention services—health and educational
- Decrease in neglect cases/ reports of neglect/ negative incidents
- Decrease in negative behavioral interventions for parents

Objective 2: Increase accessible childcare and early learning options

- Increase in availability of safe spaces for children and increase in participation in those safe spaces
- Less staff turnover in programs and more consistent care with consistency in caregivers
 - Best achieved through wage increase to motivate people to enter the field
 - Would allow more parents to get into the workforce and afford the things they need
- More parental involvement
- Increase in in school readiness and decrease in behavioral issues due to being school ready
- Accessible family-friendly work practices, which would contribute to childcare options becoming more sustainable
- Increase in affordable options/ increases in flexibility, whatever affordable means for the family
- Increase the use of the childcare scholarship funds

Objective 3: Increase family awareness, voice, influence, engagement, and knowledge

- Increase in parental or caregiver confidence
- Increased comfort and use of services
 - Measuring increase in awareness
- Increased support for parents
- Increased connections for parents with other parents, with caregivers
- Enhanced sense of connection and sense of belongings at these programs
- Increased referrals to programs and services
- Increased access to programs and services and increased participation in services



- Increase in systemic family engagement: seeing systems increase their use of family engagement frameworks, having families involved in the systems, involving families in their systems
 - Increased engagement of families in forming programs and services programming service design and quality improvement
- Decrease in need for intervention by agencies (DCYF in particular)
- Increased understanding of what does kindergarten readiness look like well before kindergarten starts

Objective 4: Enhance quality of early childhood programs and services

- All of the things already mentioned including:
 - longer workforce retention
 - o higher engagement
 - o increased referrals to primary prevention
 - o decreased behavioral health and DCYF referrals
 - increased school readiness
- Better outcomes for children—both educational, pre-kindergarten, and also health outcomes
- More engaged, vibrant workforce with a steady supply of highly trained / engaged caregivers
- Decrease in turnover among workforce
- Caregivers earn higher wages—because wages are an indicator of quality
- Increased demand for those jobs
- Increase preparedness/readiness for entering into Kindergarten or 1st grade; improved outcomes and school readiness

Additional comments, which might apply to success on any or all of the objectives:

- Increased data on who is involved and engaged and participating/ receiving services and on who is not, including whose voice isn't at the table?
- Increased access and participation on all fronts would include geographicallyconsistent geographical coverage – across the state
- more universal than broad offerings where access is needed to meet the needs, whatever the needs might be
- systematic issue of caregiver involvement and ability to influence the system
- more clear and consistent communication
