#### Summary of team purpose:

During today's meeting, the team will discuss the outcomes of yesterday's NH Strategic Plan for Early Childhood Subcommittee meeting. They will go over proposed changes to the template/initiative and discuss how to implement these changes.

### I. <u>Strategic Theme Template Discussion:</u>

The team discussed two main changes proposed at the subcommittee meeting: adding examples of incentives and how to incorporate the challenge of low wages on the early childhood for this strategic theme.

#### **Incentives Discourse**

- When we talk about professional development, include a way to incentivize people to participate in PD such as stipends, tuition assistance → will add this to the template as an example
- Stipends for what: this word popped up in the meeting; what does this mean?
  - Get money for going to training
  - Go towards gas or child care
  - Help to be specific here
  - If it is an issue of work, it is illegal not to pay someone if it is required of their work; if choosing to go to training of their own volition, it is different
    - A lot of programs close for training days, so everyone receives it at same time/same day
- Adding this to the template: Paid training time, qualified pool of substitutes, adequate training time during the workday, bonus upon completion of all annual required training hours, tuition assistance, etc.



- To speak in more general terms, promote industry recognized credentialing and continued development
- Need to build cross-field cross training
- Still want people to continue and receive college credits

## Wages Discourse

- Mention wages in the Theme 2 Templates as a challenge to recruit and retain; and, for theme 3, building an extra initiative focused on wages related to leveraging and sustaining new and existing funding long-term
- Interest in calling out the wage issue in particular for intro level folks
  - Conversation about whether this would go into our theme or another theme's team
  - Not just child care
  - $\circ$  Put it in our theme under increase workforce or theme 3 about investment
  - Wages for current workforce is just as important. Is that called out specifically?
- Large focus on pipeline and engaging young people as well as folks with a second career. Come in with very little education/experience. Need this and then have all those initiatives to help them advance if they so choose
- Wages across the board need to increase but there are so many different jobs in child care some make a good living
- Way beyond just child care wages early learning overall
- Make sure that we preface this whole plan by saying we are talking more broadly and defining the early childhood field more broadly beyond child care
  - Physical health, mental health, family support and so on
  - Need to add a bullet under important findings for implementation that says low wages are both an issue for recruiting to and maintain workers in the field
- Leveling playing field so everyone can earn a living wage
- Grants and incentives will go away → people have raised wages to get people to stay, but what happens with this money once it goes away? We have to think about a longerterm, sustainable strategy to keep wages as a livable range
  - Can't reduce someone's wage legally
  - How are we planning to sustain the wages over time?
  - Make sure we are focused on long term sustainable planning for wages within Theme 3
  - Don't know where money will be coming from in the future?
