## **Council Business (Christina Lachance)**

- Introductions
- Council Updates

Motion to approve June minutes (Tricia Tilley) Seconded (Christine Brennan) Motion approved

- PDG funds used to extend tuition assistance for early childhood education and care workforce (child care, Head Start, family child care, public school paraprofessionals)
  - Opportunity for free courses at UNH and NH's community college system
  - Expansion of eligible courses
  - DHHS funds available
  - Expected college assistance for courses in early childhood education and care
    - You must currently be working in a early childhood education and care setting (child care, Head Start, family child care, public school)
  - DHHS worked with UNH College of Professional Studies (formerly Granite State College)
- Technical assistance engagements
  - NH is participating in multiple TA engagements relative to EC Governance
  - A key takeaway NH has learned through TA engagement ismany states like New Mexico have significant state funds available
  - Capacity building

# NH's Strategic Plan for Early Childhood Crosswalk & Workplans Analysis (Lara Quiroga, Pear Associates)

- New Hampshire's Strategic Plan for Early Childhood was approved in November of 2022
- Framework
  - A lot of stakeholder feedback went into the strategic plan
  - There is a lot of work happening across the state
  - There is a need for connectivity across projects/agencies/organizations
- Pear Associates was hired to create a crosswalk and meta-analysis
  - The objective is to connect the work being accomplished across multiple funding streams/initiatives and state plans
  - Working definition of plan was developed
  - Initial analysis has begun
    - Please send along any plans not included as soon as possible
    - Pear shared the crosswalk
      - Identified gaps in plans
      - Joint ECIT identified the plans
        - Increasing workforce
          - Create workforce incentives
      - Some inconsistencies in terms
      - Opportunity for stronger linkages
      - "Equitable access" and "equity approach" mentioned but not defined.
      - Limited plans available publicly
      - ARPA funded contracts are duplicated and/or over lapping
      - Biggest gap in strategic plan theme 5 is the Office of Early Childhood.
    - Initial recommendations
      - Crate a clearinghouse of plans
      - Maintain crosswalk
      - Develop and implement as internal departmental coordination plan
        - Joint ECIT would be valuable in this work
      - Develop a glossary for terms
      - Develop a plan for community health worker training
      - Update strategic plan to include quality designations
      - Develop a process for tracking measures of success
      - Monitor Contracts
      - Leverage public/private partnerships
    - Measures of success
      - Increase in number of children enrolled in Family Centered Early Supports and Services (FCESS) (Part C Early Intervention)
      - Increase in number of children in Pre-K special education (Part B)
        - Christine Brennan questions the wording of this measure

- Should it be worded to clarify that increase would be of eligible students?
- Stating a desired measure is an increase in special education sends a mixed message.
- Rebecca Fradette states that they had a conversation regarding that wording. Agrees that the intention would be for eligible students.
- Lara responds that this meeting is not where the wordsmithing should happen
  - Investing in Part C might bring in more children in need of support
- Increase in number of children enrolled in center-based child care
- Increase in number of children public school preschool programs
- Options for families

•

- Might want to consider tracking referral sources
- Increase in family resource centers needed
- Increase childcare slots needed
  - Christina Lachance—one proposed measure was a quality improvement rating system, but it was not supported by the legislatively enacted NH Child Care Advisory Council collective
- Chris Santaniello asks who is establishing the targets and contracts?
  - Christina Lachance responds that the ECIT and departments are.
  - Chris Santaniello states variable based on contracts ending and some coming in
    - Many can be found on the fiscal dashboard
  - Trish Tilley states that we need to have a bigger conversation regarding targets and contracts
  - Christina Lachance suggests going back to the departments to discuss how to measure
  - Lara—might be helpful to revise measures annually to identify priorities for upcoming year
- Measures continued
  - Increase 3<sup>rd</sup> grade reading scores
  - Increase family resources and supports
- Questions and discussion
  - Christine D'Alessandro—is there an indicator to measure transition from part B-C?
  - Christina Lachance-not all measures are measurable at this time.
  - Departments should be able to provide data and/or in-depth view when requested
  - Discussion regarding frequency of reporting, Tricia suggest annually.

- LETRS has been very successful.
- Asks that the information regarding LETRS be shared
- Over 1000 Early Education and Care providers have signed up
- There is a \$500 stipend for the early childhood education and care workforce to participate in the P in LETRS professional development course
- Please share with early childhood education and care programs
- There was a LETRS celebration last week
- The department is finding that many childcare centers were not aware of LETRS
- There is funding available through 2025
- Feedback from administrators
  - o Finding the teachers have not previously learned about the foundation of reading

      - Early intervention screenings
        - Rebecca Woitkowski-- New Futures is happy to see childcare as part of health outcomes
    - DHHS Alignment with Council
      - Improve maternal health
        - Improve access to high quality, preventative care
        - Opportunities for healthy families
      - Determine and respond to environmental health threats
    - Shawn Jasper asks about nutrition. States that he has heard a claim that 43K NH children go to bed hungry
      - $\circ$   $\;$  Asks if anyone knows where that statistic comes from?

- If <sup>1</sup>/<sub>4</sub> of NH children are not being fed how do they learn?
- If true why is nothing being done?
- Commissioner Jasper does not believe that statistic is accurate.
- Rebecca W-There was a survey and perhaps that is where the statistic comes from?
  - How do we define food insecurity?
- NH EC strategic plan measures of success were incorporated into SHIP an example of aligning goals across state level initiatives
  - Increase in the number of NH women receiving prenatal care
